### **HOLDING OFFLINE D EI Ed PART-II EXTERNAL PRACTICAL EVALUATION PROGRAMME IN SCHOOL INTERNSHIP INCLUDING PRACTICE TEACHING (P3) OF THE STUDENTS OF THE SESSION-2019-2021**

In continuation of the previous Notification No. 08/BPE/D.El.Ed./2022 dated 20/01/2022, issued by the Board, this to notify for all concerned that Part-II-D.El.Ed External Evaluation in **School Internship including Practice Teaching (P3)** of students of the session 2019-2021, including the Supplementary and Continuing candidates of previous sessions will be held between **11<sup>th</sup> April and 15<sup>th</sup> May** in the respective institutions in accordance with prescribed procedures and guidelines in the Two Year D.El.Ed Curriculum of the Board. Details of the procedures and guidelines will be circulated among all concerned very shortly.

The concerned Heads of the D EI Ed Institutes, affiliated to this Board, are requested to call back the eligible students to take part in the final evaluation programme in April, for participation in an intensive-warm-up-session in "School Internship Including Practice Teaching" in a living school/social environment between **17/03/2022 and 09/04/2022** or prior to the holding the institution based external practical evaluation, whichever is later.

The heads of the D.El.Ed Institutes are also advised to sensitise their examinees to the spirit of school internship activities including practice teaching. **On the day of the external evaluation and during the period of such sensitisation, the institute premises should be properly sanitised and the Covid-19 protocols should be strictly maintained. All concerned, must wear masks properly and maintain physical distance appropriately.**

For smooth conduct of the said External Practical Evaluation Programme, prescribed guidelines, modalities and other details will be issued shortly by this Board.
